The Covington Township Board of Supervisors held their work session on Tuesday, November 29, 2022 at 7 p.m. at the Covington Township Municipal building, Moffat Estate, 20 Moffat Drive, Covington Township, PA 18444.

The work session was opened with the Pledge of Allegiance led by Vice-Chairwoman Williams.

Agenda: Vice-Chairwoman Williams asked that all supervisors review the agenda.

<u>Announcements</u>: Vice-Chairwoman Williams announced an executive session was held on November 21, 2022 to discuss personnel issues regarding social security.

<u>Resolution 2022-14 ~ Act 57 of 2022 Amending the Local Tax Collection Law:</u> This resolution needs to be passed by January 9, 2023.

<u>Veneski Appeal</u>: Attorney Wolff will be asking for the board's permission to enter an appearance for the tax appeal.

<u>Bracey Appeal</u>: This was not on the agenda, but Attorney Wolff reported he will have a revised stipulation for the tax appeal. This was originally approved at a previous meeting, but the school district was able to raise the amount of the assessment, so the board will need to approve the new assessment.

<u>LBA NCC Company XXIII LLC Appeal</u>: This will also have a stipulation presented at next week's meeting. Supervisor Andreoli questioned the timeframe of the tire store that is being constructed at the old McDonald's property. A permit to demolish the McDonald's was granted, but there are no further permits issued at this time. A discussion ensued on commercial development within the township.

<u>Director of Public Works:</u> Supervisor Peirce advised a survey was done on the Daleville Cemetary. Attorney Wolff suggested the survey may have been completed to help clarify the original deed since it was so dated.

<u>Police Department</u>: Chief Bastek asked the supervisors whether they would like to sell the 2014 police car or keep it for a spare after the new Tahoe arrives. This could be lettered for the zoning code enforcement, etc. and used as a township vehicle. We will also need to purchase (4) new snow tires for the 2017 police vehicle.
